**EXCERPT FROM THE CONSTITUTION**

June 4, 1984

SUBSTITUTE FOR ARTICLE 11 SECTION A, SUBSECTION 2-3 (entirely):

**2. MEMBERSHIP GUIDELINES**

a. A candidate for membership should meet the following criteria, except as provided for in paragraph A-2-b below:

(1) Be at least 22 years old at the time of admission and exhibit a maturity commensurate with his/her age.

(2) (a) Be a full-time graduate student enrolled in a recognized college or university, OR

(b) Enrolled in a recognized on-the-job training program in connection with a foreign assistance program of the United States.

(3) Contribute to the ethnic, racial, religious and gender diversity of the existing membership, rather than promote homogeneity.

(4) Give evidence of understanding and being in agreement with the letter and spirit of the principles of cooperative living outlined in this constitution.

b. Any applicants who is admitted by house members, but whose status does not conform to the guidelines in A-2-a above, must be presented by the House President to the Board Of Trustees for their consideration. The ruling of the Board Of Trustees is final and supersedes any house action.

If accepted, I agree to abide by THE PREAMBLE and THE CONSTITUTION of the Cleveland Student Housing Association and the Standing Rule of Steiner House Coop. I agree to participate actively in all House decision processes, and to fulfill all work requirements and financial obligations. I understand that failure to do so will result in revocation of my membership in the Association and expulsion from Steiner House.
