## **SECTION V-E. COMMITTEE ON UNDERGRADUATE ADMISSION.**

**V-E: Par. 1. *Membership.*** The Committee on Undergraduate Admission shall have the following membership: twelve regular members of the University Undergraduate Faculty divided equitably among the constituent faculties; the Provost, *ex officio*; the Dean of Undergraduate Admission, *ex officio*; the Undergraduate Studies officer for Freshmen; and two undergraduate students with junior or senior standing. University Undergraduate Faculty members are to be chosen by the Executive Committee for terms of three years. The Dean of Undergraduate Admission shall designate the student organization or group to select each of the undergraduate student representatives and the method of selection. Students shall serve one-year terms.

**V-E: Par. 2. *Chair of the Committee.*** The Chair of the Committee on Undergraduate Admission is to be elected by majority vote of the University Undergraduate Faculty members serving on the committee and shall serve a term of one year.

**V-E: Par. 3. *Secretary.*** The Dean of Undergraduate Admission shall serve as Secretary.
